Tree ,unidentified, on western boundary : Pollard due to excessive shading;

Tree, unidentified, on southern boundary: remove top part of tree down to level of adjoining roof line due to excessive shading;

Tree, unidentified, on southern boundary: remove top part of tree to two metres above fence due to excessive shading;

Tree , unidentified, on southern boundary: remove top part of tree to two metres above fence due to excessive shading.
