I refer to my previous submission on the 3rd August 2021 and the subsequent use having been classed as C3 (a) with the current use to provide Supported Accommodation for 16-18 year old children and young people. This application is to request for permission for a Residential home for children (C2) with potential for all the occupants being between the age range of 10-18 and limiting the number to up to 3 children or young people at any time. We will be providing 24 hour 7 days a week Care and Support staff cover with both sleep in and waking staff where required. The number of staff may fluctuate as follows depending on the needs of the children at any one time - Morning shift - up to 3 staff; afternoon shift up to 2 staff; night 1 sleeping staff and 1 waking staff (subject to the needs of the children present at any one time). There is already humble parking space for staff and visitors for up to 8 cars. The accommodation has a fairly big garden at the back which will continue to provide outdoor space for the children and staff.

MANUEL Cornwall provides Supported Accommodation placement with minimal to 24 hour on-site support and staff cover for children looked after and care leavers aged 16-18 and with a view to lowering the age to 10-16 once we have obtained Ofsted registration. MANUEL provides services and support to help local authorities in meeting the needs of those children and young people they serve. Our Supported Accommodation is aimed at supporting children/young people with high risk or high levels of need, including young people transitioning out of criminal justice, Tier 4 mental health care and those stepping into independence. MANUEL's primary aim is to assist children and young people to develop emotional resilience, healthy relationships, and practical day to day living skills, including budgeting. Plans are developed in collaboration with our partner agencies in-line with the child's/young person's age, needs and care plan, to achieve a successful transition from care to reunification and or independent living, within a safe, nurturing and caring framework.
