

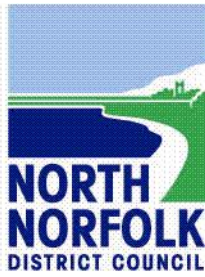

e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Group of ash (T1) - remove due to ash dieback. Higher risk of failure and damage to property. Happy to replant with suitable trees for location (next to pond)

Ash (T2) - remove over extending branches to north

Group of sycamore (T3) - crown raise to approx 5m over Road

Cherry (T4) - remove major deadwood

Sycamore coppice (T5) - remove west-most stem to prevent shading and competition with newly planted birches

Willow (T6) - reduce west side of canopy by approx 2m to prevent overcrowding of nearby oak
