e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Beech (T1) - reduce southern branch to help reduce future failure.

Beech (T2) - reduce back lowest branches conflicting with conifer hedge.

Horse Chestnut (T3) - due to previous failure and proximity to church, road and footpath I would strongly recommend reducing original framework by approximately 3 metres.
