e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Work request:

•T1 Ash. Reduce the end weight by 2-3m of the ash trees on the northern side which overhang the neighbours property. Reason: To reduce the chances of more branch failures.

•T2 Elm. Remove to ground level. Reason: The tree is leaning towards the property.

•T3 Ash. Reduce branches growing over the neighbour's house to obtain 2m clearance (secondary branches only).

Wooded Area. Remove major deadwood from 10 x other ash trees and remove 2 dead ash trees to ground level. Reason: To clear the property.
