e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

In the last 12 months the lane immediately to the south of the churchyard has been blocked by fallen trees on 3 occasions. To avoid this happening again the proposal is to remove 2 ageing laburnum trees growing hard up against the boundary wall within the churchyard and to reduce other trees at risk of falling into the lane or falling and risking damage to gravestones, in a storm as happened with Storm Arwen in December 2021.

Remove 2 laburnum trees
Trim back branches overhanging the lane of a Cupressus
Reduce the crown by 40% of ageing Cupressus
Reduce crown of remaining trunk of Portugese Laurel (the original other stems were all blown down during Storm Arwen)

In addition there is at least one hanging dead branch in the group of 3 mature sycamores, which will be removed for safety. The intention is to plant 1 or 2 new trees at a site within the churchyard that is away from any roads or lanes at a distance from the churchyard wall, taking the mature size of the tree into account. Varieties under consideration are ornamental cherry that will to 4-6 metres maximum.
