T2 Lime - Reduce 3 trunks to previous pruning points (3m) on right stem growing against Redwood to give the redwood space to fill out and balance the crown.
T7 Field Maple - Dismantle to near ground level, Top has died and tree is declining. Customers want to replant a new tree on the other side of the drive entrance
