## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T1 - Ash, fell due to heavy infection of suspected Ash die back.  
T2 - Ash, reduction of 5 meters to balance once T1 is removed, and reduce canopy sail, as suspected ADB is present.  
T3 - Lime, pollard to 10-15 meters, as canopy is in poor health.  
T4 - Oak, make into habitat stick to 8-10 meters, as a heavy reduction in the past is not suitable, and trunk is mainly dead.  
T5 - Large veteran Beech, reduction of 5-7 meters to balance as leaning, and reduce sail effect. the base has some decay in center of trunk. to give an overall reduction of 25-30%.  
T6 - Ash, reduction of 5 meters to balance, also it may need to be felled once it has been climbed to assess if retention is viable, ADB present.  
T7 - Ash, reduction of 5-6 meters, to balance as leaning over filed side.  
T8 - Walnut, 4-5 meter reduction on lower growth, and balance rest of the canopy, thin internal growth by 20%. As lower growth is out of balance with the rest of the tree, and some decay in the canopy. Remove any damaged branches.  
T9 - Oak, investigate split and reduce to make safe i necessary.  
G1 - Group of 5 x Ash, we will be dead wooding and making safe, monitor and plan future works.

The ash on site will need to be monitored and future works decided once climbed, as it is hard to tell if ADB is present at the moment, and the extent of it from the ground.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

### Sketch plan requirements

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
  - mark and name surrounding roads
  - sketch in buildings, including adjoining properties
  - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
