Details of the pre-application advice received

An initial application was dispatched to the local authority, ultimately this was returned which has resulted in this new application.

In the above noted email the planning officer, Martin Perks noted that he was concerned about the raising of eaves level and the introduction of dormer windows. Following this comment we have decided to remove the dormer windows and instead to use the looks roof lights. The eaves height we believe shouldn't be a concern, we are purely matching the insight of the rear of the building and additionally our eaves height is fractionally lower than the recently approved and constructed three bay garage in the immediate adjacent property known as Church farm. That particular building is a more visible exposed location where as our proposal is in a very sheltered hidden location, thus coming to the conclusion that the height of the eaves we believe should be acceptable.
