Conker tree

I had an application for the same tree 20/21 for the conker tree to be crowned and reduced in height. When the tree surgeon saw the tree he advised that the tree should not be reduced in height but thinned out as this would be healthier for the conker tree. Unfortunately there was a massive branch overhanging my neighbour to the rear of my property that was not taken away as was probably not noticed because no leaves. We have new neighbours who have Said the branch overhangs quite low to 1/3 of their garden and feels that it would block light once it has leaves on it. I would like to apply for this tree to have this one branch removed only.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
