T1: Variegated Poplar Aurora: reduce and reshape away from the unsheathed domestic power lines. An application for a 1 hour shutdown is in place, scheduled for 24 March 22.

T2: Deodora Cypress: remove limbs interfering with the telephone lines.

T3: Hawthorn: reduce by 20% to clear phone lines.
