T1 - Oak (TPO'd) - Perform an overall crown reduction and shaping of canopy by up to 3m from branch tips to allow more light to penetrate and to improve shape of tree (current canopy bias towards road side). T2 - Damson - Remove to ground level.
T3 - Silver birch - Perform an overall crown reduction and shaping of canopy by up to 2.5m from branch tips.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o mark and name surrounding roads

 - o add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
