# **Objectives**

To study the existing visibility of the site and review likely visual impact of a proposed campsite on the wider landscape.

## **METHODOLOGY**

The routes were identified by a desk top analysis of areas where there was the potential for views of the existing site using the visibility of field, farm buildings and wooded hanger behind benchmark.

The routes were then walked to establish where views were in fact possible, checking topography and vegetation.

The map records the routes taken and identifies where photographs were taken from (Blue Numbers).

The site is marked in Yellow.

Where the site was not visible, the route has been marked in Green. (91.0%)

Where the site is partially visible, either through light vegetation or partly visible past other buildings, the route has been marked in Orange. (6.8%)

Where the site is visible without interruption, the route has been marked in Red. (2.2%)













## 2.0 Evaluation

### 2.1 Existing Landscape Character

Littleton Farm falls within the E1 Lavant Valley area of the South Downs Integrated Landscape Character Assessment (SDILCA).

The Key characteristics of the Chalk Valley Systems are described in Appendix E of the report as;

- Broad, branching valleys carved from the chalk downs including dry valleys and coombes with smoothly rounded valley sides.
- On the shallower slopes of the valley sides the chalk soils support arable cultivation, with pasture, calcareous grassland, scrub and woodland on steeper slopes.
- Valleys often contain winterbournes (streams that only flow after wet weather) in their upper reaches - wells and springs are also characteristic features.
- In their lower reaches the valley floors contain clear, chalk rivers that flow within a floodplain characterised by permanent pasture, wet woodland, water meadows, and open water, all of which are of great ecological interest.
- Fragmentary systems of water meadows are evident historically, meadowland alongside the river was integral to the medieval sheep-corn husbandry regime, providing valuable winter and spring grazing for the extensive communal sheep flocks.
- The valleys have provided important routeways from prehistory today, they often contain a road or winding lane connecting a string of regularly spaced nucleated flint villages. Stone built medieval bridges are located at historic river crossing points.
- Farms, including distinctive flint barns, are located on lower valley sides, sheltered by trees and forming a visual focus. Gentry houses and landscape parks provide evidence of the wealthy population of the past
- Medieval/early post-medieval enclosures occur throughout the valleys, notably around settlements, indicating survival of an historic agricultural landscape.
- Remnant features relating to water management and use of the river including weirs, mill ponds and mills (relating to the former water mills) as well as fish farms, trout lakes, and watercress
- Away from transport corridors the valleys retain an unspoilt and tranquil pastoral character with dark skies.

Appendix E1 refines the key characteristics of the Lavant Valley as;

- Deep, branching U-shaped valley carved from the chalk downs and indented by coombes to produce smoothly rounded valley sides.
- Dry in its upper reaches with the main source of the Lavant at East Dean numerous wells and springs in its lower reaches.
- Shallow well drained, calcareous silty soils on the valley sides support intensive arable cultivation on shallower slopes and pasture, calcareous grassland, scrub and woodland on steeper slopes.
- The clear, chalk river flows in a narrow floodplain which is characterised by small permanent pastures divided by hedgerows, wet woodland, water meadows, and open water, all of which are of great ecological interest.
- Strong linear communication pattern comprising the A285, Droke Lane, Charlton Road, A286, and B2141 connecting a series of medieval nucleated villages at East Dean, Charlton, Singleton and West Dean, each with a distinctive church tower or spire and the river flowing alongside the village street.
- Extensive blocks of early enclosure survive throughout the valley indicating survival of the late medieval landscape.

- Remnant features relating to water management and agricultural/industrial use of the river, including relic water meadows, weirs and mill ponds. There are also water works and sewage works.
- The presence of designed landscapes, for example West Dean, provide evidence of gentry houses and landscape parks of the wealthy population of the past.
- The upper reaches of the Lavant valley, which lack visibility of main settlements, enjoy the darkest skies and have a strong sense of remoteness.

Appendix E1 defines the key landscape sensitivities as;

- Estate character of the villages.
- The 19th century designed landscapes around West Dean.
- Panoramic viewpoints over the Lavant Valley from Sutton Down, as noted in the View Characterisation and Analysis report
- Sense of remoteness and rural tranquillity around the upper reaches of the Lavant Valley (particularly around Upwaltham) that is already affected by the A285

Appendix E1 identifies key Landscape Management/Development Considerations Specific to the Lavant Valley as;

- Conserve the estate character of the villages and designed landscape around West Dean.
- Pay particular attention to panoramic views over the Lavant Valley in planning any change.
- Conserve the remote rural character and associated dark skies around the upper reaches of the Lavant Valley.
- Ensure that any road upgrades associated with the A285 and A286 are integrated into the rural valley landscape by means of careful siting, materials and design.
- Monitor water quality in the Lavant and seek to minimise water pollution resulting from intensive dairy farmina

Littleton Farm forms the top of the upper reaches of the Lavant Valley, Extending from its source at Dunton Down to the village of Upwaltham with Landscape Character Areas B1 to the South and East and B2 to the North and West with panoramic views across the scarp and down the Lavant Valley from the tops of the Hills on either side of the valley.

The Farm buildings sit in the valley floor on the North West side of the A285 with the campsite location at the foot of a small wooded hanger called Warren Bottom to the South West of Littleton Down and North East of North Down with steep slopes up to higher ground on each side that provide a sense of enclosure to the campsite that adds to the sense of remoteness identified in the SDILCA but more open views toward Sutton Down and Upwaltham Hill to the South East of the site provide visual connection, where the farm buildings shield the site from the A285.

## 2.2 Existing Visibility

This landscape assessment was undertaken in February 2022 using photographs taken at the time and on previous visits to Littleton Farm in August 2014 and the winter of 2016/17.

The vantage point map at 1.1 indicates both the location of the photographs and colours indicate the footpaths surveyed, with red sections indicating where clear views are possible and orange where partial views are possible with interruption from vegetation or other buildings

The survey was conducted on the 3<sup>rd</sup> February 2022 and of the 14.72 Km of path walked, the field at the base of Warren Bottom where the campsite is proposed was visible for 0.32Km (2.2%) between viewpoints 5-8 and partly visible for 1Km (6.8%) with occasional views between and over trees at significant distance from the North East side of Sutton Down (Viewpoints 1-3), the North West side of Glatting Beacon (Viewpoint 29) and on the path across Burton Down toward Denture (Viewpoint 32).

Despite the campsite's close proximity to the South Downs Way as it rises up Littleton Down (Viewpoints 9-16) the form of the hill and steep sides of Warren Bottom mean that the campsite is not visible. Similarly, views from the bridleway descending North Down also offer no views of the site with North Down Copse of the shoulder of Warren Bottom obscuring any view of the site.

The A285 runs in the base of the valley and through a combination of its low elevation, high roadside hedges, the shoulders of Warren Bottom and the buildings at Littleton Farm, the campsite is not visible from the road.

While the campsite enjoys views of Upwaltham Hill and Sutton Down, exploration of the Bridleway that rises up Upwaltham Hill and traverses Sutton Down, reveals no public views of the site with Shepherd's Copse, West Wood and the crest of Sutton down preventing views into Warren Bottom when the angles past the shoulder of Warren Bottom would allow.

The footpaths to the North of Denture toward Barlavington Down similarly pass behind Farm Hill whose plantations and altitude prevent views into the base of Warren Bottom where the campsite is proposed and when sufficiently far North to see past Farm Hill, the slope of the side of Littleton Down adjacent to Warren Bottom prevents any view of the campsite.

Therefore the public views of the site are limited to;

• The South Downs Way directly opposite Littleton Farm base as it exits the woods on the dipslope from Littleton End for about half the distance to the A285 (Viewpoints 5-8), where parts of the field to the South West and a small section at the top of the field to the North (outlined in Red on the photo below) can be seen over the farm buildings but not the East side of the field DOUGLAS BRIGGS that remains obscured by the shoulder of Warren Bottom adjacent to Littleton Down.

It is worth noting that the appraisal photos were taken in February when there are no leaves on the trees and during Summer the visibility of the farm buildings is significantly reduced with the following image from August 2014 showing the difference.

• The South Downs Way descends from Sutton Down toward Littleton End where partial views of the only the very top end of Warren Bottom are possible over the trees of Scotcher's Bottom (Viewpoints 1-3).

In addition to the significant distance of these views and the small part that Warren Bottom has to play in them and, while not visited in 2014 to provide photos, it is likely that the site when viewed from Glatting Beacon and Burton Down would be much less visible in summer when the trees are in full leaf and these zoomed photos can reasonably be regarded to present the 'worst case' (most visible) situation.

### 2.3 Proposals

The following is an aerial photo showing the extent (outlined in Red) of the proposed camping field at Warren Bottom that would only operate during the summer months, the access along an existing farm track (Dotted Red), Water point locations (White Triangles), parking area and access to existing showers in the farm buildings (White Circle).



The applicants allowed camping at Warren Bottom to take place (within permitted development rights as a temporary use), with visitors allowed to pitch a tent anywhere within the field (outlined in Red) but the applicant's noted that they tended to remain on the more level ground within the middle third of the site. While vehicles are allowed onto the field to set-up, they would be parked within the farmyard close to the shower facilities within the existing buildings (White circle) and not allowed to remain on the fields. There are a number of water points along the East side of the field (White Triangles) and in 2021, the applicants provided temporary sanitary facilities (porta-loos) stationed close to the existing water points.

It is notable that the appraisal of existing visibility has identified the East boundary and middle third of the field as the least visible from public vantage points not showing up in any of the viewpoints.

## 2.4 Assessment and Mitigation

It is unlikely that the appearance of a tent in a field on the downs would give rise to a fundamental change in landscape character. However, the provision of on-site facilities and any permanent features do require consideration, together with the intensity of use.

The application proposed the use of the field for up to 20 pitches at any one time for a 'season' between March and September and when the applicants conducted a short trial, they provided between 3 and 5 mobile porta-loos on the field near the existing water points.

Vehicular access to the field follows an existing farm track and the low intensity of the use and distributed nature of tents when camping, coupled with the requirements to park the cars within the farmyard indicate that the vehicular access should be no more intense or intrusive as normal farming activities and therefore also unlikely to result in significant adverse effects.

The location for the water points are co-incidentally well sited from a landscape perspective, positioned close to the existing hedgerow and in a location on the field that is not widely visible in the landscape.

The positioning of porta-loos, while not entirely alien in a farming landscape (often used when farm hands are working the fields) could potentially be an issue if their presence continued through the winter months and they became a 'permanent' feature.

It is therefore proposed to mitigate the potential impact of the porta-loos by requiring them to be positioned close to the hedge-line on the East side of the site (where least visible in the landscape) and require their removal at the end of each 'season'.

A litter strategy is also considered relevant to prevent degradation of the landscape and potential impacts on wildlife. The applicants have indicated that it is their intention to use the site as grazing land when not used for camping so this may become a 'self-policing' issue.

## 3.0 Conclusion

It is no con-incidence that the applicants have prepared their proposals for the campsite with careful consideration for the character of the landscape as it is the strong sense of remoteness of the upper reaches of the Lavant Valley that they see attracting their customers (visitors to the South Downs) to DOUGLAS BRIGGS use their campsite and they would not wish to see this character eroded in any way.



It is unlikely that the appearance of a tent in a field would give rise to fundamental change and conserving the remote rural character and associated dark skies around the upper reaches of the Lavant Valley have been a key consideration when assessing the proposals.

This evidence gathered for this landscape appraisal has been extensive with all likely areas for publically accessible views visited, photographed, considered and assessed.

Despite the proximity of the campsite to the South Downs Way, its location within the foot of a wooded hanger (Warren Bottom) significantly limits the visibility of the site with very few publically accessible views of the site.

Where the site is visible from public footpaths, these have been considered in detail, with consideration given to Summer and Winter conditions and the relative visibility of the campsite field.

With this in-depth knowledge of the site visibility, potential impacts from site facilities have been minimised with elements positioned in the least visible locations and mitigation measures recommended to ensure that the character of the landscape is not degraded by the camping use.

By its very nature a campsite use has a very low and temporary impact and in limiting the number of pitches, carefully positioning facilities and managing the site to reduce vehicular access and mitigate litter, the character of the landscape is unlikely to be harmed.
