Scots Pine

Fell and replant tree (T1) due to maturity age and covered top to bottom in Ivy

Remove Ivy from base location and replant new tree of same species (8-10 CM Girth) in the same spot or on one of the 2 north positions on Map

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - $\circ\;$ showing the approximate distance between the application tree(s) and buildings
 - $\circ\;$ adding other relevant features on the site (e.g. greenhouse, paths)
