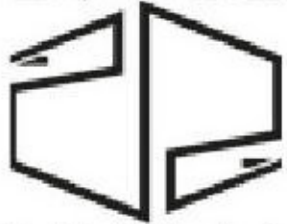
I would be grateful if you can hold the validation/registration of this application as we found out we need to serve notice to other owners along the private road leading to this property.
