Large Sycamore tree, identified as 'T1' on the submitted Sketch Plan.

Permission to carry out Crown reduction up to 4m and even up the balance of the crown away from the property side. There is a rotational stress fracture from high winds to limbs overhanging the property which needs to be removed to make safe.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
