



7.1 Risk of flooding from rivers and the sea

7.2 Historical Flood Events



Modern urban drainage systems are typically built to cope with rainfall events between 1 in 20 and 1 in 30 years, though some older ones may flood in a 1 in 5 year rainfall event.

10.1 Sites of Special Scientific Interest (SSSI)




