- T1 Holm Oak front left of house to pollard reducing crown by 3m
- T2 Sycamore located in Church to rear of property to remove overhanging growth up to 8m
- T3 Sycamore located in Church to rear of property to remove overhanging limbs up to 5m
- G1 Yew/Holly located opposite outbuilding to rear of house to reduce width of hedge by up to 2m to re-establish hedge and screen to a more manageable height and size.
- G2 next to G1 to reduce to 2.4m (8ft) and reuce width as above to re-establish and reshape hedge into a more manageable height and size.
