T1-Copper Beech

Large mature tree previously crown reduced with now dense and extensive regrowth.

Tree has not been worked on since 2012 and 2002 before that.

Encroaching over neighbouring property and buildings

Suggested works are to reduce the crown back to form a more compact shape,

approximately 4m from branch tips to just above the previous pruning points.

Retain as much furnishing growth as possible and as natural and flowing a canopy outline as possible

The reasons for these works are to maintain the tree relative to its surroundings and carry on from previous maintenance strategies.

Several sections have fallen off the tree and there are numerous dead branches throughout the crown.
