X1 horse chestnut TPO

Reduce height by up to 3m and reduce lateral spread by 1-2m to balance and shape

Reason - Poor form and signs of canker, close to property and blocks light, shading build up of moss and blocks guttering, suppressed adjacent to Neighbour trees whilst causing die back on adjacent cedar, to mitigate root spread and root growth affecting garden, to mitigate branch failure
