This application is for the removal of a very old rotten Apple tree that has many hollows inside the trunk and is on a lean.
The tree is 3m in height and 2m wide.
We would also like to remove the small Willow tree next to the garden wall.
The tree is very close to the wall and if left to grow could cause future damage.
The tree is 4m tall and 2m wide.
All work will be compliant with BS3998 standards.
