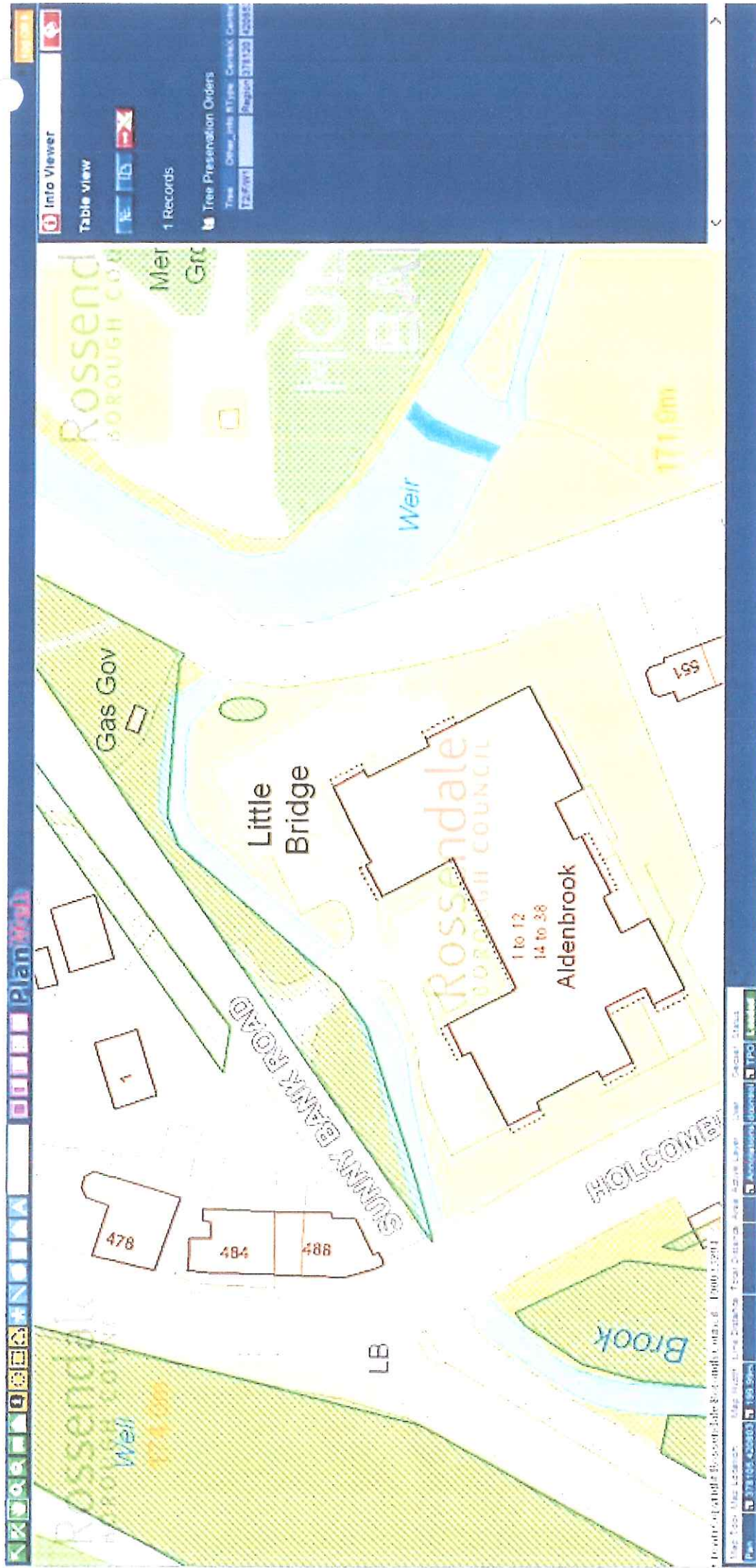

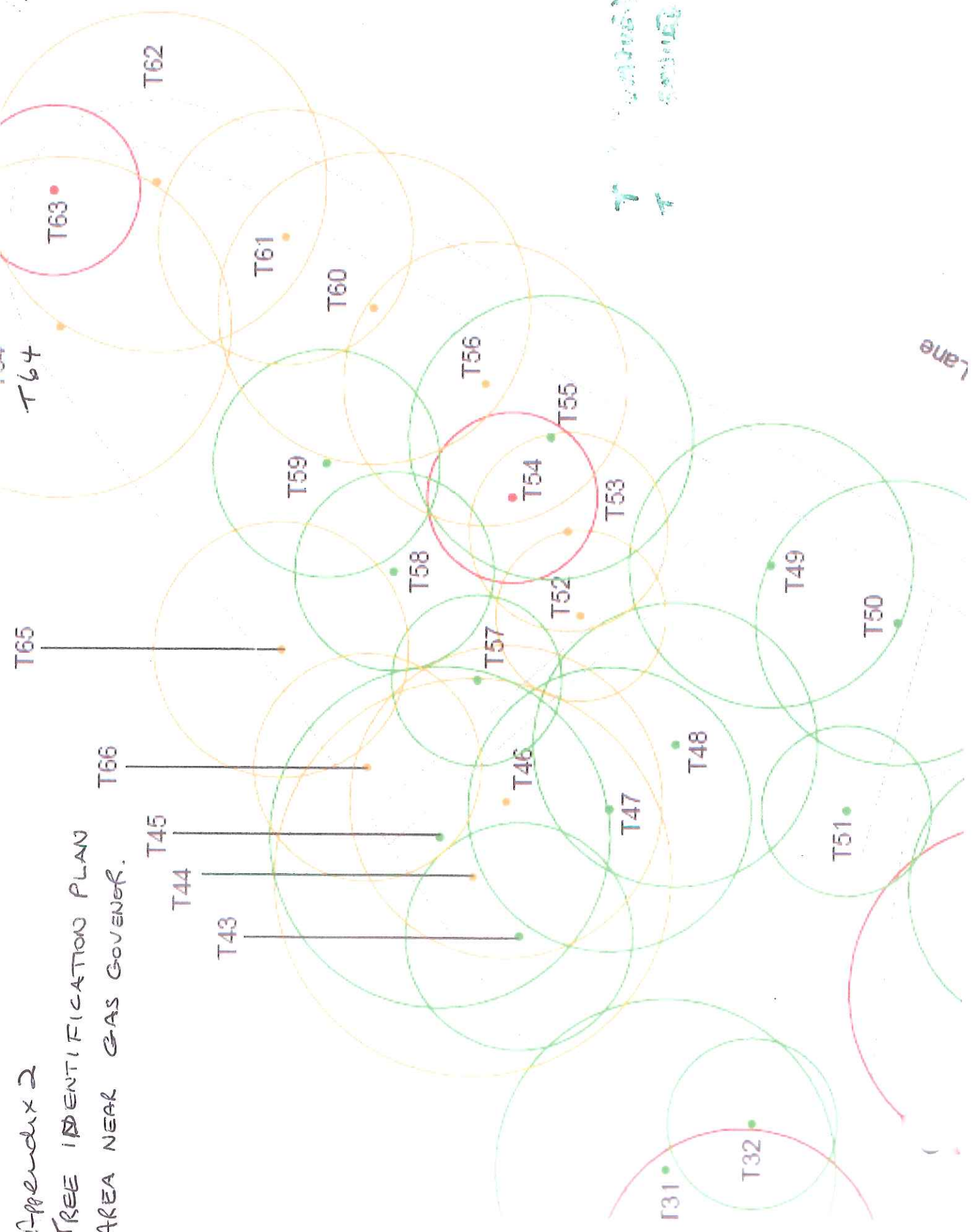

Application to Rossendale BC for Tree Work.

Answers to Question 7 of application form.

See Appendix 2 - Tree identification plan for triangle shaped area around the gas governor.

Tree 62, marked with identifying number, is a large ash tree with one large limb overhanging Free Lane. It is suffering very badly from dieback disease. More than 50% of the crown is infected. Our tree surgeon - Mark Taberner from Belmont Tree Surgeons - and two other experts that have seen it recommend that it should be felled.

Tree 53 - no identifying number - and Tree 59 - has an identifying number - are both smaller ash trees infected with dieback. Our tree surgeon and two other experts that have seen them recommend that they should be felled.

Tree 55 is is a mature horse chestnut. Whilst examining the ash trees noted above our tree surgeon identified that it was suffering from honey fungus and recommended it should be felled.

Due to the significant number of other existing trees around our boundary and their close proximity to the public highway we are not proposing to plant replacement trees. But we would welcome the opportunity to discuss this proposal with you on site.
