 - My late husband and I obtained planning permission for a replacement house at Woodlands Lodge in 2005 (NFDC ref: 04/83225).
 - 2. Towards the end of 2005, whilst the new house was under construction, my husband installed a small window in each end of the house at first floor level to give light to the roof storage area. I recall there was some discussion with the Council about this at the time, but I'm not aware that anything came of it. Following the completion of the house in 2006 he then installed a staircase into the roof space, and the roof space was converted into two bedrooms and a bathroom. This is the same arrangement that remains today.
 - In May 2011 my husband purchased and himself installed a velux window into one of the two
 tirst floor bedrooms. Then in March of the following year (2012) he purchased and installed a
 second, identical velux window in the other first floor bedroom.
 - There is now produced to me and marked "MW1" copies of receipts for the purchase of these velux windows.
 - 5. I can therefore confirm that there has been a staircase to the first floor since 2006 and that all of the windows in the first floor and roof of Woodlands Lodge have been in place for in excess of ten years.




