
Particulars of proposed works:

Western Power Distribution has a proposed project to move an electricity pole and underground some low voltage overhead power lines in Flintham in 2022. The works have been requested by a landowner to allow the refurbishment of a property in the vicinity. At the time of the works, Western Power Distribution will also replace the overhead conductor on the line that is remaining with Aerial Bunded Conductor. The overhead line will continue to operate at the same voltage.

Please see attached plan which shows the overhead line to be replaced highlighted in red and the old pole position at Point A. The new overhead line is highlighted in blue with the new pole position at Point B.
