To remove 9 conifer trees and a small birch and various shrubs which are not native to the area or innkeeping with the Hall from the rear of Hilton Hall. There are several pear trees which will be retained to create an orchard within the same area. The trees will be removed including stumps to encourage the orchard to grow.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
