- Holly Tree
- T2
- Reduction of Holly Tree by 3m as part of a "hedge" reduction as they are very close to the house <2m. This is also to facilitate home working as the "hedge" is blocking mobile broadband to the nearest mast in Newent. The "hedge" is higher than the apex of the roof and makes it green and if damaged in winds would fall into the house causing damage.

I have spoken to an arborist who has recommeded a 3M hedge reduction which includes T2 on the following plan:

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
