Full specification of the proposed work is included in the inset panel on the plan submitted with the application (we are aware that the removal of deadwood does not require consent but it is included for completeness).

The reason for the works is for the amenity and enjoyment of the new private gardens by incoming residents and the safety of pedestrians using the new footpath beneath the trees' canopies. The works are intended to strike an appropriate balance between maintaining the health and form of the trees whilst maximising the amenity and enjoyment of the new residents.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
