Scotts Pine - defined as T2 in Paul Watts - ARBORICULTURAL ASSESSMENT REPORT

Remove entirely to ground level and replace with a minimum large standard fastigiate form tree species. The removal of this one tree would have an insignificant impact on the landscape profile of the location and will allow for the start of a phased removal and replacement programme to ensure the maintenance of visual amenity for the long term. It is likely a Planning Inspector would concur with this view should an appeal be required.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
