T1 - Oak - Remove to ground level and remove stump. This work is being undertaken as the roots of this tree are lifting the tarmac on the drive and the tree is planted centrally reducing the usability of the drive, street parking is very limited at the front of the property due to the narrowness of the street. Any repairs to the tarmac will simply result in the same thing damage happening causing significant financial outlay over the coming years for Mr Jonathan Courtney. Mr. Courtney wishes to remove the tree and replace with 2 fastigiate Hawthorns or similar at the front of the property.	

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
