Identification of Tree(s) and Description of Works				
Please identify the tree(s) and provide a full and clear specification of the works you want to carry out				
To fell what is believed to be a Goat Willow (may be a hybrid) immediately alongside the road and drive of 4 Wheatleys Close.  The willow is detrimental to the beech hedge below it (beech hedges are a characteristic of the village), reduces light to the front of the property, restricts access into the drive, interferes with cables to neighbouring properties, but primarily, because when the wind blows, the ground at the base of the tree can be seen to move. To the NE (drive) and SE (road) there is a drop in the level of the ground reducing the support at the base of the tree.  It is not intended to plant a replacement tree due to lack of a suitable location in the garden following the earlier planting of other trees.  The Goat Willow is estimated to be 10m high. It is about 25 years old having grown from a self seeded sapling since we moved here.				
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
  - o mark and name surrounding roads
  - o sketch in buildings, including adjoining properties
  - o add house numbers or names

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - o marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - o adding other relevant features on the site (e.g. greenhouse, paths)
