Further to your email below, we comment as follows:

1 - You acknowledge that you received the application on the 9th March; it has taken until the 28th April to receive an initial response.

2 - I was assured on the phone with one of your colleagues this morning that this application would be treated as a priority to ensure it is validated as soon as possible. Requesting a Biodiversity Survey and Report at this stage is only going to cause further delay to the validation.

3 - Application reference 21/02117 was granted permission on 4th November 2021; a biodiversity report was not requested or submitted as part of that application. It also required roof works of a similar nature.

4 - Please see attached site photographs - the property is a recently constructed dwelling built to a high standard with slate as the roofing material. Roosting opportunities for bats are extremely minimal, if at all. A biodiversity survey would clearly state this and would not require an emergence survey.

We would therefore request that you consider the information above and remove the request for a biodiversity survey in order to validate the application.

In addition, I confirm that all submitted plans/drawings are accurately and metrically scaled as detailed on the plans/drawings and can be scaled against for planning purposes.

Given point one above, we would be grateful for a prompt response.
