T1: Deodar Cedar, to the north of the Granary, Tarlton, in the communal courtyard.

The application is to remove 2 codominant stems, potentially reduce the crown if necessary (not anticipated to be by much). Further reduce the tree laterally by up to 30% and to crown lift to approximately 4 metres.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
