Identification of Tree(s) and Description of Works
Please identify the tree(s) and provide a full and clear specification of the works you want to carry out
Elder (T1 to T6): Fell T1-T5 due to low amenity value, to make way for fruit trees. Remove T6 due to close proximity and competition with adjacent, more mature, Willow tree. Willow (T7): Fell due to low amenity value and to allow better connectivity of land with existing garden.
Beech (T8 and T9): Remove mis-shapen limbs (growing horizontally or with significant warping) of trees at field border due to close proximity and competition with adjacent trees and low amenity value.
Context: Tree works being undertaken as part of project to turn neglected piece of land adjacent to Close Cottage into usable space, including removal of discarded building materials; clearance of overgrown weeds; fencing; replanting fruit trees at the top of the site to restore into what was historically an orchard; and maintaining an area of woodland at the bottom of the site.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
