The original proposed drawings showed a rendered finish but described a finish the same as the existing materials. On the original drawings we were hoping to build a section of the east wall in the original materials but, whilst removing the brick work for removal of old supporting timber in the walls and floor joists, we have not managed to salvage enough of the bricks for reusing and the brickwork on the existing storey is in poor condition. Our updated drawings and proposal show that we would like to leave the house in the original material and render the extension. The brick work we have managed to salvage will still be used on the original house to replace poor brick work. The materials used will be block work and render. At this stage we are unsure of the type of render we will be using but the finish will be in a shade of white, smooth/slightly textured and will not be pebble dash finish. **Site Visit** Can the site be seen from a public road, public footpath, bridleway or other public land?
