I must also point out that approval under Building Regulations may also be required for the proposed development, for which a separate application must be made. Please contact the Building Control Office on (01536) 464171 for further information.

Please be advised that due to the high volume of applications being received, there will likely be delays in reaching a decision. If your application is affected the case officer will be in touch to advise further and/or seek an extension of time beyond current decision making targets, as necessary.
