Major Residential-led, Mixed Use Development Land at Greenferns, Aberdeen LDP Sites OP33 & OP28 Newhills, Aberdeen

For Aberdeen City Council

12 May 2022

#### 1.0 Site Address

- 1.1 Land at Greenferns, Aberdeen Local Development Plan Sites OP33 & OP28, Newhills, Aberdeen.
- 1.2 The site extends to approximately 79.9ha and is located on the western edge of Aberdeen, to the west of the existing residential area of Northfield and south of the Bucks Burn. Kingwells lies approximately 1km to the west of the site.
- 1.3 The majority of the site is identified within the adopted Aberdeen Local Development Plan 2017 as Opportunity Sites OP33 & OP28, for around 1,470 homes and 10ha of employment land.

### 2.0 Description of Proposal [PoAN Note 2]

2.1 A major development proposal comprising a residential-led, mixed use development comprising approximately 1,650 homes, employment use, neighbourhood centre comprising local retail and commercial provision, leisure and community uses and associated infrastructure including new and upgraded access roads, landscaping, open space and engineering works.

## 3.0 Proposed Consultation Strategy [PoAN Note 6 & 7]

- 3.1 In light of current regulation and guidance, it is considered appropriate to undertake a hybrid public consultation strategy. This will involve an initial virtual consultation to be undertaken via a dedicated online website for the proposal. Thereafter, a more traditional face-to-face public drop-in exhibition will be held. This pre-application engagement strategy will therefore meet the statutory requirements of The Town and Country Planning (Development Management Procedure) (Scotland) Regulations 2013, The Town and Country Planning (Miscellaneous Temporary Modifications) (Scotland) Regulations 2022.
- 3.2 On the week commencing **Monday 6<sup>th</sup> June 2022**, mailshot invites will be circulated to all residential and non-residential properties within the site and a 50m radius of the site boundary confirming details of the public consultation, dedicated website and arrangements for the public drop-in session. Letters will also be sent to the Community Councils and Ward Members who are listed in the PoAN form to provide advance notice of the consultation and to formally invite them to attend the proposed virtual and public events.
- 3.3 A poster and leaflet drop will also be undertaken around public buildings and local businesses situated in close proximity to the site, advertising the consultation events and inviting attendance from the public. A list of drop sites is provided in section 5 below for review.
- 3.4 On the week commencing **Monday 13th June 2022**, a newspaper notice will be published in The Press and Journal, providing the details relevant to both the online consultation and public exhibition events. A draft newspaper notice is provided in section 4 below for review. On the same day, a dedicated consultation website will go



- live, displaying details of: the proposal; the proposed virtual and public events; and how participate, and instruction of how to provide feedback on the proposed development.
- 3.5 Feedback forms will be made available on the consultation website from the day of activation, commencing the period of 'one-way' consultation. Participants will have the option to complete the feedback form directly via the website, or the form can be downloaded, filled out and sent back to Ryden via email or by post.
- 3.6 Details will be provided in both the newspaper notice and on the consultation website on how requests can be made for exhibition materials and feedback forms to be posted to interested parties.
- 3.7 The virtual event is proposed take place over the course of an afternoon and evening during the week commencing **Monday 21st June 2022 between the hours of 3.00pm and 7.00pm**. This will take the form of a live, interactive session hosted on the consultation website, where attendees can join and submit comments and queries to the Design Team via a 'live chat' portal. This will commence the period of 'two-way' consultation. Where possible, the Design Team will answer queries as they are received. Any queries which require more detailed consideration will be responded to after the event, with the attendee advised accordingly.
- 3.8 The additional in-person event will take the form of a public drop-in exhibition to take place during the week commencing **Monday 5th July 2022 between the hours of 3.00pm to 8.00pm**. This will be held at This will be held at an appropriate venue, in relatively close proximity to the site, which is readily accessible to the public. Details of the proposed development will be displayed in addition to feedback received to the virtual consultation. Members of the Design Team will be available to discuss the proposal and answer any queries. A visitor register will be kept and feedback forms will be provided which can either be completed at the event or taken away and returned by post to Ryden.
- 3.9 Feedback on the proposal can be provided up to **Friday 29th July 2022** when the consultation will close.
