T 1: Cypress (corner of house): Remove, cutting stump as close to ground level a possible. Reason: Has little amenity value, will allow more light to penetrate house.

T 2: Yew: Reduce crown by 30% and balance Reason: To manage size of tree and allow greater light penetration

T 3: Holm oak: Reduce crown by 30% and balance Reason: To manage size of tree and allow greater light penetration

T 4: Sycamore: Reduce crown by 30% and balance Reason: To manage size of tree and improve its form.

T 5: Yew: Remove major deadwood. Reason: For safety reasons and to improve visual impact of tree
