Carry out a crown reduction reducing height by approximately 2m and lateral growth by up to 2m where necessary to balance the crown and to reduce overhang of summer house. Over extended branch growing towards the house, reduce back by approximately 4m to reduce loading. Canopy raise by reducing back to source the smaller epicormic growth up to the first primary limb on the left hand side at approximately 8m

T2 Ash tree. As per findings in tree survey. Dismanlte the tree to ground level
