Tree in the parking area of 10 Spen Lane to the West of the property.

We would like to fell this tree as it is dead. It has had no buds or blossom and now has no leaf growth unlike other blossoms on the street.

It poses a safety risk as has started to drop branches, one of which I have walked into in the dark.

We do not propose to replant a tree in this location. The current tree arises from a small gap in the block paving of the driveway and we believe it would be impossible to replant into this small gap retaining roots.

The tree is numbered T2 on the drawing submitted.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
