Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T12 – Magnolia – reduce crown by 1.5m on height and 1m on overall spread, lift crown to 1.8m above ground level – hand saws should be used in this operation.

T13 – Oak – reduce lateral crown spread by around 3.5m on the northern side and 2.5m on all other areas, a height reduction of 2-2.5m would help to balance the crown and create an acceptable aesthetic appearance, lift crown to 6m above ground level by pruning off small diameter – around 10-20 mm epicormic branches.

T14 – Oak - reduce lateral crown spread by around 2.5m on all areas and height by 2-2.5m, lift crown to 6m above ground level by pruning off small diameter – around 10-20 mm - epicormic branches.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
