

Introduction

This report is submitted as part of a Full Planning Application for the redevelopment of Edward Street Hospital. This Design and Access Statement gives a high level overview of the project, documenting the design work and development carried out at RIBA Work Stages 2-3 for the Dormitory Eradication scheme at Edward Street Hospital.

The dormitory eradtication scheme is for the remodelling of Edward Street Hospital (ESH) on its existing site in West Bromwich to provide two new 15x bed Older Adult mental health wards. The hospital currrently accommodates dormitory style inpatients beds. Though throughout the pandemic this bed number has been significantly reduced owing to the social distancing requirements of the dormitories. It is proposed that the new accommodation will be individual ensuite rooms.

Site

The site is located on Edward Street in West Bromwich. It is situated on the edge of the boundary of the High Street West Bromwich Local Plan, and bounded on one side by the local Metro train stop. It was formerly a densely built up site for what was the former Edward Street Hospital, as we have found from old aerial photographs in 1946. It was redeveloped in 1985 by the Percy Thomas Partnership in Birmingham to the Post-Modern concrete frame with brick facade that we see today.

It is currently in use as dormitory style mental health accommodation for Older Age Adults. There are also Outpatient facilties (TARU), Catering and Staff Facilities and Office space. The building is owexclusively by ned and used the Black Country NHS Foundation Trust.

Whilst not being located in the West Bromwich High Street Conservation area, the building is immediately adjacent, and as such the design should be sympathetic to this important setting.











Existing Edward Street context, 2021

Local Plan for High Street, WB




Site

The existing approach to the Main Entrance and Reception is framed by pillars incorporating historical memorial stones with inscriptions. The entrance is clear and easily visible from both directions along Edward Street. The remaining building frontage features a line of trees, breaking around the entrance.

This is to be retained as an approach, with the removal of the canopy above the pillars due to its difficulty to clean and maintain.

The existing vehicle access and car park immediately to the North-West of the building are to be retained.


Part of the quality of the site both public fronting and private are its established gardens and trees. This provides a buffer between the activity of the neighbouring street and the Hospital. The value of external amenity space is important to the future development, both for patients and as contribution to the streetscape.











The proposed Adjacency diagram highlight the functional drivers for the new layout and set out the basis for segregating patient, public and support zones





The proposed demolition incorporates the East Wing of the existing building as well as adjacent Conservatories and canopies. The entrance canopy and a high level bay window will also be removed to enable to proposed building footprint.



Dormitory Replacement Needs



Dormitory Eradication

It is proposed that the existing 4-bed dormitory rooms will be replaced with individual ensuite rooms. For buildaibility and MMC purposes, they will be back-to-back ensuites with accessible risers to the corridors.

As these are to be Older Age Adult mental health wards, the Trust selected from the P22 Repeatable Rooms layouts a more traditional shape of room and ensuite.

These are the Single Nested Ensuite layouts, modified for this design with leaf and a half doors. The sizes and shapes of these rooms informed the concept, shape, size and layout of the proposed design.

P22 Repeatable Room Layouts

The aim of the P22 Repeatable Rooms is to improve patient outcomes whilst reducing the cost of construction through standardisation. These layouts are consistent with the requirements of Government Policy.

Within the latest version of the P22 Repeatable Rooms and Standard Components there are 3 different types of Mental Health Bedroom Arrangements, with different furniture configurations.

- Functional Inboard (Ensuite Bedroom)
- Organic Inboard (Ensuite Bedroom)
- Organic Nested (Ensuite Bedroom)



Design Development

A series of Options were developed to understand how much of the existing building could reasonably be retained.


The chosen option incorporates partial demolition and new build with minimal refurbishment of existing

The hybrid option requires only the left wing of the existing building to be demolished, whilst maintaining the Lighthouse, TARU/Outpatients, ECT, Office spaces and Meeting rooms. Several of these areas would be repurposed to provide some of the new accommodation.


The new build provides 2x modern 15 bed mixed wards; one functional and one organic, plus new staff, tribunal and therapy areas. These wards are stacked; the ground floor for organic with access to an internal courtyard and external ward gardens. The functional ward would be located on the first floor, where a ward terrace garden would be provided. The existing building would be treated with a light refurbishment only.

Further variations of this option were also explored, for example providing a shell or full fitout of 1x HDU ward in the existing building.

Early Concept Sketch showing the evolution of the Ground Floor Departmental Layout



Concept

It is proposed that the individual ensuite rooms (yellow) will wrap around the perimeter of the new build extension, with appropriate circulation points for access and fire escape (blue).

This 15 bed ward will wrap around an internal courtyard on the ground floor. A thicker corridor with rooms to both sides will run along the final side of the internal courtyard. These areas will be for patient day / dining spaces (red) and staff areas (pink).

The existing entrance (Lighthouse) will be retained, with a discrete access to the new build to allow for ambulance and private entrances for patients to access the wards.

On the first floor, there wil be another 15 bed ward, with a first floor ward terrace garden, that will overlook into the main courtyard garden. See next page for details.


Ground Floor Plan

The new build will be a larger footprint than the existing building, but there will be an internal ward garden and a first floor ward terrace which will bring nature into the heart of the new building extension. Garden spaces are an important part of the development for patient access to the outdoors with benefits for health, wellbeing and exercise opportunities.

Engagement

It was of the utmost importance that the new building be fit for purpose, and this required the engagement of the existing users of the building, which would assist with enhancing the design and making it a truly user led design process.

Apart from the weekly engagement meetings with the Trust and the design team to work through design issues, we have also held two staff engagement sessions in the Edward Street Hospital.

The first session was at the earliest possible point in the design process, to allow us to understand how the existing hospital was used and to work into the design any improvements that the staff could suggest.

The second session we brought our more in depth proposals, with visuals, 3D views and plans that would illustrate our design process and assist with conversations with the staff.

Each session proved to be very worthwhile and engaging. Feedback was positive, and the staff felt included and that their thoughts were heard.

Further engagement has been carried out with via a Pre-Application Meeting with the local authority on 21st December. The façade treatment of the new building was altered as a result of feedback from this meeting to be more sympathetic to the existing building. A copy of the minutes is provided in the appendices of this report.











MATERIALITY - CONTRASTING BRICK

Green glazed brick against the existing red brick was proposed to create a rhythmic playful materiality contrast for the new facade. It would be a contemporary and prominent change of colour for Edward Street. Brick is selected for its robustness and sympathy to the local vernacular.

MATERIALITY - STANDING SEAM

As the brick detailing is depicted mostly in horizontal string courses, we considered a vertical standing seam design that would constrast this, to enhance the difference between the existing building and the new facade.

ISLINGTON SQUARE

Award winning FAT Architecture Housing Scheme for New Islington

FAT were selected unanimously by the future residents to design 23 new houses for the Manchester Methodist Housing Group within the New Islington development by Urban Splash. The £2.3 million scheme comprises of 23 two to four bedroom family homes and garden areas. The design unifies the residents' desire for traditional homes with the New Islington masterplan commitment to innovative and world class architecture, and was developed in close collaboration with the residents.




