RESPONSE FROM HARRY DOE - TREE OFFICER :-

I have taken a look at all the information. Currently the position of the fence and relationship to the trees is favourable.

The trees are within a conservation area so an application to work on any live part of the tree is required, including the roots. In my opinion moving the fence back is likely to require both pruning the canopy and to the root system of the trees. This is likely to stress the trees and lead to their decline. I would suggest the fence is in suitable position and I would not support the request to move the fence.
