

1.0 INTRODUCTION

- 1.1 David Tucker Associates (DTA) have been commissioned on behalf of A H Brown Farms to review the transport implications for Phase 2 of Treestacks Farm proposed poultry unit expansion on land northwest of Redhouse Farm, Oakley Road, Wix, Manningtree, Essex. The site location and plans of the proposals are attached at **Appendix A**.
- 1.2 Planning permission was granted for a Poultry unit on the site under planning Consent 20/00194/FUL. Conditions 5, 6 and 7 of the consent required a new access from Oakley Road, visibility splays and internal manoeuvring areas to be completed in accordance with approved details. Internally works have been completed and the access is currently being constructed to details approved by ECC.
- 1.3 Condition 11 of the consent required the submission of a Traffic Management Plan. This was submitted and has been formally agreed under Application 20/01551. The approved documents are attached at **Appendix B** and will also be applicable to the new application.
- 1.4 This report has been prepared in accordance with the NPPF and the Guidance on Transport Assessments (GTA) issued by DfT. Although the GTA document has been withdrawn, the methodology and guidance it contains is still relevant. The NPPF document states that all developments that generate significant amounts of movements should be supported by a Transport Statement or Transport Assessment.
- 1.5 The Government's sustainability objectives are embodied in the National Planning Policy Framework (July 2021) and in terms of developments in rural locations, NPPF advises that:

"Planning policies and decisions should enable:

- the sustainable growth and expansion of all types of business in rural areas, both through conversion of existing buildings and well-designed new buildings;*



- *the development and diversification of agricultural and other land-based rural businesses;*
- *sustainable rural tourism and leisure developments which respect the character of the countryside; and*
- *the retention and development of accessible local services and community facilities, such as local shops, meeting places, sports venues, open space, cultural buildings, public houses and places of worship."*

1.6 The TS considers the potential transport and highways impact of the proposals including the impact of the development generated traffic on the capacity and safety of the surrounding road network. The report concludes that the proposals will have no adverse impact on the safety or capacity operation of the surrounding road network.



2.0 EXISTING CONDITIONS

2.1 Site Description

2.1.1 The site is located to the north of Oakley Road. Great Oakley is located approximately 1.4km to the south east of the site and Wix approximately 1.8km to the west. The location of the site is shown at **Appendix A**.

2.2 Surrounding Road Network

2.2.1 Oakley Road ranges from 4.5 – 5.5m within the vicinity of the site and routes east to west. The road is classified as a Priority 2 (PR2) road which means it is a main rural feeder for HGV's to use. To the north it connects users the village of Wix and the A120 and to the south with Great Oakley.

2.3 Existing Traffic Flows

2.3.1 To understand existing traffic movements along Oakley Road, a 7-day automated traffic count (ATC) was undertaken between 11/03/2022 and 17/03/2022, and a summary of the five-day weekday average flows is provided in **Table 1**. A copy of the data including location is attached at **Appendix C**.

2.3.2 It can be seen in **Table 1** that HGV movements constitute 3.5% of the total vehicle movements. The overall level of traffic has reduced slightly since the original application (which was based on surveys in 2018) but remain broadly consistent.

2.3.3 On the week of the survey the existing Phase 1 site was operational but at the end of the cycle, so generated movements of wash and bedding lorries (Tuesday – Thursday) and an egg delivery (one vehicle) on the Saturday.



2.4 Existing Vehicle Speeds

2.4.1 The average and 85th percentile speeds along the A417 based on the ATC data identified in **Section 2.3** are summarised in **Table 2**.

2.5 Personal Injury Collision Data

2.5.1 Personal Injury Collision (PIC) data has been obtained from Essex County Council and the latest 5-year period has been assessed from 01/01/2017 to 31/12/2021. There were no collisions recorded along Oakley Road.

2.5.2 This is an improvement on the situation in 2019 for the previous application when there had been 2 accidents in the preceding five years.



3.0 DEVELOPMENT PROPOSALS

3.1 Overview

3.1.1 The proposals are for Phase 2 of the poultry unit expansion and the site plans include:

- 3 No. Poultry Buildings;
- Feed Bins; and
- Attenuation Pond.

3.1.2 Each unit will be of standard construction of steel-framed, fully-insulated buildings. The building will be clad externally with profiled sheeting coloured.

3.1.3 The existing site houses 88,268 birds per flock. The proposals will increase the bird capacity to 220,670 birds.

3.2 Site Access

3.2.1 The poultry unit will be accessed via the bell mouth approved for Phase 1 which has been agreed with the Local Highway Authority and constructed with a width of 8m and 15m radii. Visibility splays of 4.5m x 160m to the east and 2.4m x 160m to the west can be achieved.

3.2.2 The detailed design of the access as approved by consent 20/00194/FUL, is agreed with ECC and the works about to commence. Plans of the approved scheme are attached at **Appendix D.**



4.0 TRAFFIC GENERATION

4.1 Existing Development

4.1.1 The existing generation associated with the operation of the site can be seen in **Table 4**.

4.2 Proposed Development

4.2.1 Fertile eggs will be delivered to the site on Day 1 and will be reared on the site for approximately 40 days, following which they will be removed live to the processors. Following the removal of the birds, the site will be empty for around 10 days for cleaning and preparation for the next flock of birds. The site will operate with approximately 7.2 flocks of birds per annum.

4.2.2 Following manure removal, the building will be washed out with high pressure power washers and prepared for the incoming flock. The inside of the building is drained to a sealed concrete dirty water tank which will be emptied following each cleanout of the building by tanker.

4.2.3 A summary of the total number of movements generated for the existing and proposed poultry unit is summarised in **Table 4** below.

- 4.2.4 The proposed poultry unit expansion will generate an additional 80 two-way HGV movement a flock cycle (40 in, 40 out).
- 4.2.5 On the busiest days of the flock cycle; day 33, 40 and 41 the development will generate 20 two-way HGV movements (10 in, 10 out). The peak movements will only occur three times per flock cycle. The proposed poultry unit will operate with 7.2 flocks per annum.
- 4.2.6 In addition to the commercial traffic there will be 1 member of staff generating 2 two-way movements per day. There will also be 1 visit per quarter from vets, inspectors and field officers.

4.3 HGV Routing

Feed Delivery/ Bird Deliveries/ Removal

- 4.3.1 In terms of local routing, all traffic will route out of the site towards the A120 north west of the site. This follows the same traffic management as the existing operations, associated with Phase 1 (**Appendix B**). Tracking Assessments as previously approved / agreed with ECC are attached at **Appendix E**. This confirms no off-site widening is



required. For the reasons discussed below, the position remains unchanged with the proposed extension.

- 4.3.2 Feed will route from Edge Green via the A1066, A140, A14, A12, and the A120. The chicken factory is located at Eye in Suffolk so will route along the A140, A14, A12 and A120.
- 4.3.3 Manure will go to Fibro in Thetford so will route along the A120, A12, A14 and then the A134.



5.0 TRAFFIC IMPACT

5.1 Highway Impact

- 5.1.1 The maximum movements for the proposed poultry unit will be on day 33, 40 and 41 of each cycle during bird removal with up to 20 two-way movements (10 in, 10 out).
- 5.1.2 This is an increase of 5 – 6 loads (10 – 12 movements) per day on day 33 and one on day 41. Previously it was assumed that no movements would take place on day 40.
- 5.1.3 Overall the level of traffic generated in any one day is not going to change materially from that already found acceptable. The increase in one HGV per day over that the consented position can have no material or noticeable impact.
- 5.1.4 The number of days that this level of traffic will occur, will increase from one day per 45 flock cycle to three days. Again in the context of the local highway network and the controls already secured for the consent this is not material.
- 5.1.5 It is clear that the intensification of the site will not result in a detrimental impact on the operation or safety of the existing highway network.



6.0 CONCLUSIONS

- 6.1 DTA was commissioned on behalf of the applicant A H Brown Farms to review the transport implications for Phase 2 of the proposed poultry unit expansion on land northwest of Redhouse Farm, Oakley Road, Wix, Manningtree, Essex.
- 6.2 The proposals include 3 No. broiler sheds to increase the bird capacity to 220,670 birds.
- 6.3 A review of the personal injury collision data has confirmed that there were no recorded collisions in the latest five-year period.
- 6.4 On the busiest days of the flock cycle, days 33, 40, 41 the development will generate an additional 20 two-way HGV movements (10 in, 10 out). The peak movements are during bird removal at the end of each flock cycle.
- 6.5 All traffic associated with Phase 1 will follow the same management traffic plan as the existing operations.
- 6.6 The additional movements are modest and are well within daily variations of traffic flows.
- 6.7 It is considered that the intensification of the site will not result in a detrimental impact on the operation or safety of the existing highway network.
- 6.8 The Transport Statement has demonstrated that the development is fully in accordance with both national and local policy and in particular confirms that the impact of the development is not severe. On this basis, it is concluded that there are no grounds for refusal on highway grounds.

1.0 INTRODUCTION

1.1.1 This Traffic Management Plan has been produced to outline the management strategy for controlling the HGV movements associated with the proposed construction and ongoing operational use of 2 no. poultry units located on land north west of Red House Far, Wix. The planning application reference is 20/00194/FUL.

1.1.2 This Traffic Management Plan has been prepared to discharge Condition 11.

1.1.3 The site is located to the north of Oakley Road. Great Oakley is located approximately 1.4km to the south east of the site and Wix approximately 1.8km to the west.


2.0 HGV ROUTING

2.1.1 All HGV vehicles accessing or departing from the farm are to follow the routes set out below. The inbound and outbound routing will be as follows:

Inbound details:

1. From Horsley Cross roundabout follow the A120 East to the Ramsey Roundabout then U-turn to travel west along the A120 – see **Figure 1**.
2. Take the left at the A120/ Harwich Road junction into Wix.
3. Take first left at War Memorial onto Oakley Road.
4. Proceed for 0.6 mile to the farm on the left.

2.1.2 Outbound details:

1. Depart the farm by turning right onto Oakley Road.
2. At the junction onto Harwich Rd follow the route shown on **Figure 2** – all HGV's must pass to the left of the junction, before turning right onto Harwich Road.
3. Join the A120 westbound and proceed to Horsley Cross.

2.1.3 Representatives from Essex Highways have noted during their site visit that other HGV's of the size that will be travelling to and from the farm (but not associated with the farm) also undertook the same inbound and outbound manoeuvre proposed for deliveries as part of this application at this junction.

3.0 Site Management

3.1 Site management will implement the following initiatives to ensure that the operation of the site does not adversely impact the safety and operation of the adjacent highway network.


- All HGV movements to and from the site will be restricted to a designated access route. The Route Card is attached at **Appendix A**. The route information will be provided to all drivers, employees and contracted staff to ensure that the route is known. The routing agreement will be strictly adhered to by suppliers.
- Suppliers, as a condition of contract will have HGVs fitted with modern satellite tracking devices and hands-free cab telephones. The HGVs and the operators at the poultry unit will be in contact with one another to ensure vehicles do not meet one another along Oakley Road and at the site access.
- HGVs delivering to the site will be scheduled to allow a reasonable time window to avoid clashes. As part of the contract documentation all drivers of HGVs will be



informed of the procedure to contact the site 30 minutes prior to arrival to ensure that there will be a clear route.

- Any HGVs within the site about to depart when an HGV is due are to be kept within the site until the route is clear.
- Contact details for the Poultry Unit Site Management are to be provided to the Local Planning Authority with a review mechanism to annually appraise the operation of the site.

Outbound Route




