Dear Louise,

I have just reviewed the case again, and as it stands the application would be refused in its current form.

We have received objections from:

Glynde & Beddingham Parish Council  
Design and Conservation Officer

The main issues are considered to be as follows:

Whether the land is previously developed according to NPPF definition

Conflict with policy SD27 of Local Plan, which requires at least 80% of new dwellings to be 2-bedroom or 3-bedroom (additional reception rooms are counted as bedrooms as per the policy)

Excessive scale and size

Visual dominance and bulk

Detracting from views within the Conservation Area

Impact of light pollution on Dark Night Skies designation

My contact at the National Park has agreed the recommendation to refuse on these grounds, and I will await your response. Going forward, I think we would need more evidence of the site being previously developed land (it appears overgrown and blended into the landscape) and any new dwelling would need to be smaller in scale, and no more than 3-bedroom. We would also expect the scale and design detailing to be more in keeping with the adjacent buildings, but this in itself does not rule out a more contemporary approach of course.

I hope this is of assistance, and apologies for the delay getting back to you.
