## Identification of Tree(s) and Description of Works

Species: Beech

T1: Location: Front of 6 Ferndale Drive

Proposed Works: Permission to fell.

Rationale: The tree is completely blocking out all natural light and warmth to the front of the property during daylight hours leaving the house and front garden in complete shade. The lack of natural light and less than optimal internal temperature necessitates a disproportionate use of lighting and heating during daytime hours. The mess caused by falling debris is also a continuous problem, the volume of catkins, spent beech nut husks, branch drop and leaf fall presents year round problems. Increased branch drop is especially problematic causing hazards and injury to both occupants and property; the volume of leaf fall and spent husks is also problematic causing hazards to both occupants and property, covering the entire garden, drive, side passage as well as blocking guttering and down pipes. The volume of pigeon droppings is also a significant and notable health hazard, with droppings evident on the facade of the property, windows and doors as well as to vehicles parked in the vicinity of the house and the drive way of the property. The hazards are also evident inside the property as pigeon droppings and other debris are invariably brought into the house via footwear and transferred to carpeting and flooring presenting increased risk to the occupants as well as damage to carpets. The roots are also causing damage to the pavement and garden edging. The pavement has been previously repaired but the tree roots have continued to cause damage necessitating further repair. The need for continued repair of the pavement is clearly evident due to the upward push of the roots due to the restrictive nature of the trees setting. As well as creating numerous issues for the homeowner due to its size and dominant overshadowing of the property, the tree is creating similar issues to the occupants of the neighbouring property giving rise to associated hazards and risks to their young children and vehicles. Due to its location on a small residential cul-de-sac bordered by adjacent woodland the tree does not provide substantial amenity value to the area. It is not readily distinguishable from surrounding woodland foliage, nor is it prominently visible beyond its cul-de-sac location when viewed from adjacent roads and highways.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
