Introduction

This planning application is for a single storey, stone extension set within the courtyard of Stotfold Barn, 12 Back Lane, Collyweston.

The extension is a large, single storey extension, set within a secluded couryard. The existing property is a converted barn of stone construction, as well as timber siding and a slate roof. Whilst the extension is large in scale, this is to preserve the elements such as the door in to the courtyard which site at a higher level relative to the courtyard level.



The Existing Dwelling - The residents wish to add a kitchen extension to the dwelling, due to their current kitchen being in one open plan kitchen, living and dining room and smells, odour and noise being an issue in the open plan converted barn space.

Property as Existing

The site as shown; the site has stepped levels to the courtyard as shown.



To the South of the extension lies the residents garage and rear wall of no 14.



The West of the site overlooks open farmland and is well screened by mature trees as shown.



Proposal

The proposed works aim to integrate the dwelling in to its context, through the use of high quality design, materiality and workmanship, to ensure the proposal sits sympathetically in the context in. The existing dwelling has a thorough use of stone, however in a more rustic context of a barn. The proposal aims to create an ashlar clad extension of high quality design, to contrast yet be sympathetic with the existing dwelling.

The design of the extension is characterised by a symmetrical, frontage, with glazing to one side overlooking the fields south of the site.

Parking:

The parking is unaffected by the proposals.

Landscaping:

The landscaping to the site will be broadly as existing.

Drainage:

The drainage to the extension proposed will be in to the existing drain.

Boundary Treatments:

All boundary treatments are to be as the existing

Environmental:

The proposed development will be constructed out of a timber/ traditional construction of high quality insulation, with vernacular materials such as Stone and Oak.

Access:

Access is unaffected to the dwelling and is considered not improved or made worse.
