Details of the pre-application advice received

Due to the presence of a pond within 100m of the house we re asked to undertake a bat survey. A bat nursery was found by the Bat Conservation Trust. This meant we needed to remove the re-roofing element from our previous application to allow time for the survey and decide on what works would be possible. This application now takes the bat nursery into account with evidence from the Bat Conservation Trust.
