The dormer windows in the attic bedroom are rotten and letting in water and need replacing. Also some tiles re broken/missing and also letting in water. Therefore we propose to erect scaffolding to front of house, remove peg tiles to front of house and ridge tiles, remove cement render from dormers and replace, remove rotten windows from dormers and replace using painted softwood and slimlite double glazed units. Re-felt and batten roof, re-instate existing tiles if usable or replace broken tiles (to be agreed). Re-lead both dormer windows with new lead, redecorate and remove scaffolding.
