A plan is attached and I also attach a photograph of the tree. The tree can be felled in my own garden.

## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

The tree in question is a tall pine (c. 25m) in my garden that is more exposed than it was when I had several nearby trees removed last year. I had intended to keep it but I am told by the tree surgeon that it is at risk of falling over in a high wind due to it being more exposed. I think it best removed rather than wait for it to fall into the churchyard. The tree is not well liked in the village with many feeling it "sticks out like a sore thumb'. I do not intend on replacing the tree at this point in time although further down the line I may put some fruit trees in the area.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
