Please describe the proposed works	To remove our existing oil tank and boiler and install an air source heat pump with unit mounted within 1m of neighbours boundary line (as shown on uploaded project plan), due to movement of our rear door and rear extension (both already passed) along with the position of the sewer manhole and positioning of shed/pet space we will be fitting, the most suitable place would be as proposed, this would also mean the unit would be facing away from our's and our nighbour's property rather than across or towards, this would surely be better from a noise point of view. We have also looked into noise reduction fence panels that could be installed along the boundary line replacing existing standard panels if required. Although no work has been started to install the unit we have already upsized all our radiators and installed the electric supply in the correct position. We were due to install with a local company who had assured us that the db calculation (based on a 'Mitsubishi Ecodan R410a ultra quiet PUHZ monobloc' also uploaded) had been accepted for this position, after concerns over this and other issues they could not provide any evidence as to who had accepted it and hadn't told us that we needed to obtain planning permission, so regrettably we had to cancel the project with them at that stage.
